**PREFATORY QUESTIONNAIRE:** To get you ready for the meeting and able to participate in the Workplace Personality Traits segment, please take 20 minutes to answer a short questionnaire prior to the meeting. The presenter needs time to collect and analyze the responses – in addition to be able to return to you an individualized report. The questionnaire opens by asking you for contact information and then moves to questions/statements that describe your behavior, at home and work. Answering the questionnaire isn't mandatory – but we encourage all our members to participate. When answering the questionnaire, focus on how you see yourself communicating with others in a professional and casual work environment. The questionnaire should take no longer than 20 minutes and we recommend completing it uninterrupted. Go with your gut feelings and don't over-analyze the questions. There are no right or wrong answers -- since these are not psychometric tests. Just enjoy the process and look forward to learning more about yourself and others at the meeting.
